**NOTICE OF PUBLIC HEARING, BUDGET VOTE AND ELECTION
ROOSEVELT UNION FREE SCHOOL DISTRICT
ROOSEVELT, NASSAU COUNTY, NEW YORK**

NOTICE IS HEREBY GIVEN that a virtual public hearing on the proposed budget for the Roosevelt Union Free School District for the 2020-2021 fiscal year will be held on May 28, 2020 at 5:00 p.m. Information as to how to join and participate in the virtual Public Hearing can be found on the District's website: <https://www.rooseveltufsd.org>.

AND FURTHER NOTICE IS HEREBY GIVEN that the annual vote and election will be held on Tuesday, June 9, 2020 via Absentee Ballot to vote upon the following items:

1. To adopt the annual budget of the School District for the 2020-2021 fiscal year in the sum set forth in the budget estimate (*proposed budget*) heretofore filed pursuant to law, and to authorize the levying of a tax upon the taxable property of the District for such purposes.

2. To fill the following vacancies on the Board of Education:

For a term of three (3) years, commencing on June 9, 2020 and ending on June 30, 2023 (Belinda Monroe, last incumbent).

For a term of three (3) years, commencing on July 1, 2020 and ending on June 30, 2023 (Alfred T. Taylor, last incumbent).

3. To vote upon such other propositions as may properly come before the voters.

AND FURTHER NOTICE IS HEREBY GIVEN that a copy of the statement of the amount of money that will be required to fund the School District's budget for the 2020-2021 fiscal year may be obtained on the School District website -www.rooseveltufsd.org- by any resident of the District during the fourteen (14) days immediately preceding the annual election, commencing on **Tuesday, May 26, 2020**.

AND FURTHER NOTICE IS HEREBY GIVEN that Section 495 of the Real Property Tax Law requires the District to attach to its proposed budget an exemption report. Said exemption report, which will also become part of the final budget, will show how the total assessed value of the final assessment roll used in the budgetary process is exempt from taxation, list every type of exemption granted by statutory authority, and show the cumulative impact of each type of exemption, the cumulative amount expected to be received as payments in lieu of

taxes and the cumulative impact of all exemptions granted. In addition, said exemption report shall be posted on any bulletin board maintained by the District for public monies and on the School District website.

AND FURTHER NOTICE IS HEREBY GIVEN that individuals interested in running for the Board of Education may declare themselves to be a candidate for the Board of Education provided that they submit a statement that includes the candidate's name and residence, along with the seat for which the candidate is running including the name of the incumbent and the length of the term to be filled to the District Clerk by emailing her at ppratt@rufsd.org no later than 5:00 p.m. on May 11, 2020. Each vacancy is a separate and specific office and a separate declaration is required for each separate office.

AND FURTHER NOTICE IS HEREBY GIVEN that no absentee ballot will be canvassed unless it is received at the office of the District Clerk no later than 5:00 p.m. on the day of the election, June 9, 2020. A list of persons to whom absentee ballots have been issued will be available in the office of the District Clerk.

AND FURTHER NOTICE IS HEREBY GIVEN that personal registration of voters is required either pursuant to § 2014 of the Education Law or pursuant to Article 5 of the Election Law. If a voter has previously registered pursuant to Section 2014 of the Education Law and has voted at an annual or special district meeting within the last four (4) calendar years, he or she is eligible to vote at this election; if a voter is registered and eligible to vote pursuant to Article 5 of the Election Law, he or she is also eligible to vote at the annual vote and election. All other persons who wish to vote must register as set forth below.

Due to the COVID-19 pandemic, the Board of Registration will not meet for the purpose of registration. If you are not currently registered to vote, you can register with the Board of Elections by filing an online application with the Department of Motor Vehicles that will enable the District to transmit an absentee ballot to you for this election, provided that you register by June 4, 2020. The online DMV voter registration can be found at <https://dmv.ny.gov/more-info/electronic-voter-registration-application>.

The register will be filed in the office of the District Clerk.

AND FURTHER NOTICE IS HEREBY GIVEN that Military Voters who are not currently registered may apply to register as a qualified voter of the District by submitted a Military Voter Registration Application to the District Clerk, no later than 5:00 p.m. on May 14,

2020. A copy of the Military Voter Registration Application is available both in the office of the District Clerk and online located at the District's website at <https://www.rooseveltufsd.org>. A Military Voter is entitled to designate a preference to receive a Military Voter Registration Application, Military Ballot Application or Military Ballot by mail, facsimile or electronic mail. Such designation will remain in effect until revoked or changed by the voter. If no preference is designated, the District will transmit the military voter registration by mail.
